1st Meeting "Club of TwiNSol-CECs Interest"

University of Novi Sad, Faculty of Technology Novi Sad (TFNS) Novi Sad, Serbia

April 27, 2023

The 1st Meeting of "Club of TwiNSol-CECs Interest" was organized as a one-day event on April 27, 2023, at the Faculty of Technology Novi Sad, University of Novi Sad, Serbia. It is the activity planned within the Work Package (WP) 6 of the TwiNSol-CECs project (101059867) with the main goal to establish interactive contacts with potential stakeholders with interest in the TwiNSol-CECs topics of research with the purpose of transfering the project results and the latest knowledge on the environmental presence of CECs. This first Meeting was organized as an event for introductory presentation of TwiNSol-CECs goals and possible collaboration pathways with stakeholders, either through the session with oral presentation given by the TwiNSol-CECs members or during the afterwards discussion during the *B2B coffee* break. The program of the Meeting is presented in the Annex of this report (this is the translation from the Serbian, as the official language of the meeting was Serbian).

Besides TwiNSol-CECs project team members and colleagues from TFNS, 16 representatives of 11 institutions attended the Meeting of the Club as presented in Table 1. The potential stakeholders were invited by sending the official invitation to the institutions from various sectors, either local and national administrations, public utilities, water management, food industry, NGO, public health, secondary schools, SMEs, etc. Majority of the invited stakeholders delegated representatives at the Meeting.

At the start of the 1st Meeting Prof. Dr. Biljana Pajin, Dean of Faculty of Technology Novi Sad, Project Manager for the legal, administrative, and financial issues, and WP6 Leader, gave a welcome speech, stressing the importance of the collaboration with stakeholders, including the innovative and applicative aspects of the research, as well as the increased attractiveness of the Faculty's educational role, in that way. Afterwards, Prof. Dr. Zita Šereš, Vice-dean for Science at Faculty of Technology Novi Sad and Project Manager for Strategic Issues, highlighted the importance of cooperation between academia, business, and society given by the national scientific strategy, and summarized the achievements of the Faculty so far with the position and importance of TwiNSol-CECs. Prof. Dr. Nataša Đurišić-Mladenović, Project Coordinator, presented main goals and consortium of TwiNSol-CECs project, emphasizing the importance of expected project results and outcomes for the joint efforts towards zero waste emission. Dr. Igor Antić gave a presentation on "Emerging compounds (Contaminants of Emerging Concern, CEC) – global challenge in the field of







environmental protection", introducing the attendees to the problems induced by the occurrence of such compounds in the environment, and the contribution of the TwiNSol-CECs project in the field of analysis of CECs in water.

The last presentation was held by dr Nikola Maravić, leader of the task dealing with the organization of the Club of TwiNSol-CECs interest, and Project Communication Coordinator, who provided information on different means of cooperation between the stakeholders and Faculty of Technology Novi Sad (particularly TwiNSol-CECs team) within and beyond TwiNSol-CECs project. He announced the questionnaire for acquiring potential inputs and interest of stakeholders in the TwiNSol-CECs research and collaboration. The questionnaire will be distributed before the summer brake to all attendees of the 1st Meeting of the Club, who gave the consent to be included in the emailing list by signing the List of Participants of the 1st Meeting.




